Overview

- Today, the FAO released four reports that review the Government of Ontario's (the Province's) spending plan as outlined in the 2025 Ontario Budget.
- This analysis was undertaken in response to a request from a Member of Provincial Parliament and is part of a planned series that reviews the spending plans for five ministries:
 - Health and Long-Term Care, which form the health sector;
 - Education;
 - Colleges, Universities, Research Excellence and Security (MCURES); and
 - Children, Community and Social Services (MCCSS).
- For additional information on the five ministries' 2025-26 spending plans, see the FAO's *Examining Ontario's 2025-26* Expenditure Estimates, which compares planned spending against actual spending over the previous four years to the standard account level of detail.































Spending Plan Overview






































Health Sector Spending Plan

- In the 2025 Ontario Budget, the Province projects that health sector spending will grow at an average annual rate of 0.7%, from \$91.6 billion in 2024-25 to \$93.6 billion in 2027-28.
- This is a significantly slower pace than the 6.6% average annual growth over the previous three years.


Health sector spending plan in the 2025 Ontario Budget




Health Sector Spending Plan

- The FAO estimates that health sector spending would need to grow by an average annual rate of 4.0% over the next three years to maintain 2024-25 health sector service levels.
- Compared to the FAO's cost driver projection, the 2025 budget spending plan has a funding shortfall of \$3.4 billion in 2025-26, \$6.4 billion in 2026-27 and \$9.6 billion in 2027-28.


Comparing health sector spending growth, FAO cost driver forecast vs. 2025 Ontario Budget, 2024-25 to 2027-28




Ministry of Education Spending Plan


- In the 2025 Ontario Budget, the Province projects that Ministry of Education spending will grow at an average annual rate of 2.5%, from \$40.1 billion in 2024-25 to \$43.2 billion in 2027-28.
- This is a significantly slower pace than the 8.3% average annual growth over the previous three years.





Ministry of Education Spending Plan

- The FAO estimates that Ministry of Education spending would need to grow by an average annual rate of 3.2% over the next three years to maintain 2024-25 ministry service levels.
- By 2027-28, the 2025 budget plan is below the FAO's cost driver projection by \$0.9 billion.




MCURES Spending Plan

- In the 2025 Ontario Budget, the Province projects that MCURES spending will decrease at an average annual rate of -3.3%, from \$14.1 billion in 2024-25 to \$12.8 billion in 2027-28.
- This is a significantly slower pace than the 10.1% average annual growth over the previous three years.

MCURES Spending Plan

- The FAO estimates that spending consistent with maintaining 2024-25 ministry service levels would result in an average annual decline of -2.1% over the next three years.
- In 2026-27, the 2025 budget spending plan exceeds the FAO's cost driver projection by \$0.3 billion, and in 2027-28, the 2025 budget spending plan is below the FAO's cost driver projection by \$0.5 billion.








MCCSS Spending Plan

- In the 2025 Ontario Budget, the Province projects that MCCSS spending will decline at an average annual rate of -0.5%, from \$20.7 billion in 2024-25 to \$20.4 billion in 2027-28.
- This is a significantly slower pace than the 6.7% average annual growth over the previous three years.

MCCSS Spending Plan

- The FAO estimates that MCCSS spending would need to grow by an average annual rate of 4.2% over the next three years to maintain 2024-25 ministry service levels.
- Compared to the FAO's cost driver projection, the 2025 budget spending plan has a funding shortfall of \$1.5 billion in 2025-26, \$2.4 billion in 2026-27 and \$3.1 billion in 2027-28.










Funded Hospital Beds








Long-Term Care Beds






Provincially Funded Nurses








Personal Support Workers

Physicians






Total Provincial Health Sector Funding




Provincial Funding for Hospitals






Spending on Physicians






Hospital Beds












School Board Operating Spending








Licensed Child Care Spaces

Canada-Wide Early Learning and Child Care (CWELCC) Program

- Under the CWELCC program, the Province committed to:
 - reduce the cost of licensed child care for children under the age of six to an average of \$10 per day by September 2025, which was subsequently revised to the end of March 2026; and
 - create 86,000 new child care spaces for children under the age of six relative to the end of 2018-19, for a total of 375,111 spaces that would be enrolled in the new CWELCC program by the end of 2026.
- The FAO estimates that the CWELCC program will cost \$4.2 billion in 2025-26, \$5.2 billion in 2026-27 and \$5.4 billion in 2027-28.
- Under the current CWELCC agreement, which is scheduled to expire in March 2026, the FAO estimates that there are sufficient funds remaining to support the cost of the program in 2025-26.
- In March 2025, the federal government announced a funding commitment of \$16.8 billion over five years to support the renewal of the Canada-Ontario CWELCC agreement, including an estimated \$3.2 billion in 2026-27 and \$3.3 billion in 2027-28.
 - Based on the federal government's proposed funding levels, the FAO estimates that there would be a federal funding shortfall for the CWELCC program of \$1.9 billion in 2026-27 and \$2.0 billion in 2027-28.


































School Board Spending














Colleges Spending


















Universities Spending




Domestic Tuition Fees








ODSP Spending

- The FAO estimates that the average monthly number of ODSP cases will increase from 372,681 in 2024-25 to 402,639 in 2027-28.
- Based on prescribed increases in ODSP allowances, the FAO estimates that the average inflation-adjusted (i.e., real) allowance will grow from \$15,981 in 2024-25 to \$16,073 in 2027-28.
- Based on the projected increase in cases and prescribed increases in allowances, the FAO estimates that ODSP spending will increase from \$6.2 billion in 2024-25 to \$7.2 billion in 2027-28.
- This increase in spending is higher than the funding allocated to the ODSP in the 2025 budget.






OW Program Spending

- The FAO estimates that the average monthly number of OW cases will increase from 282,011 in 2024-25 to 330,684 in 2027-28.
- As OW allowance rates are currently frozen, the FAO estimates that the average inflation-adjusted (i.e., real) allowance will decline from \$9,455 in 2024-25 to \$8,891 in 2027-28.
- Based on projected increase in cases and assuming no change in allowance rates, the FAO estimates that OW spending will increase from \$3.3 billion in 2024-25 to \$3.7 billion in 2027-28.
- This increase in spending is higher than the funding allocated to the OW program in the 2025 budget.








Social Assistance Payments








Social Assistance Recipient Share
